The Alliance recommends that artists register their work with their country's Copyright Office for international legal protection. The Alliance does not accept any responsibility for loss or damage of any kind and does not insure the artwork.

I authorize the Alliance to scan, reproduce, transmit and display my artwork, in black-and-white, duotone or color, electronically for on-screen viewing and in printed publicity related to this exhibition and to Alliance programs, on a non-exclusive, royalty-free and worldwide basis.
